

AN ORDINANCE amending Chapter 10.14 of the Grays Harbor County Code and Ordinance 422, providing for additional county roads in Grays Harbor County upon which to operate wheeled all-terrain vehicles.

WHEREAS, Ordinance 422, as codified in chapter 10.14 of the Grays Harbor County Code, sets forth provisions allowing the use of wheeled all-terrain vehicles (“WATV”) upon certain county roads under certain terms and conditions, and imposing penalties for violation; and

WHEREAS, the Board of Commissioners finds that amendment of Ordinance 422, as codified by Grays Harbor County Code Chapter 10.14, is necessary to revise the beginning and end points with regard to the usage of WATVs on Wishkah Road, and to add additional county roads to the list of approved roads upon which to operate WATVs in Grays Harbor County, now therefore

Be it ORDAINED by the Board of Commissioners of Grays Harbor County as follows:

Section 1. Grays Harbor County Code Section 10.14.020, (Ordinance 422 § 2, 2015) is amended to read as follows:

Except as otherwise provided in RCW Chapter 46.09, a person may not operate a wheeled all-terrain vehicle (“WATV”) on any county road in Grays Harbor County except within the roadway of those county roads and segments of county roads designated below as approved for operation of wheeled all-terrain vehicles.
