This contract is to provide Supportive Employment/Day Program services for individuals with developmental disabilities.

2. Request Approval, Amendment No. 1 to an Agreement with Grays Harbor River of Life Fellowship for the Dads Matter Program, term of contract March 1, 2016 through February 28, 2017, \$29,480: A motion was made, seconded and passed to approve Amendment No. 1 to an Agreement with Grays Harbor River of Life Fellowship for the Dads Matter Program, term of contract March 1, 2016 through February 28, 2017 in the amount of \$29,480 and is funded by Treatment Sales Tax dollars.. Dads Matter is an education and support curriculum designed to address and remediate the issues leading to fathers having their children removed by the State and placed in foster care. The amendment alters the contract term to last a full year from March 1, 2016 through February 28, 2017. The amendment also clarifies the description of allowable services under the grant, and the reimbursement method for those services.

Commissioner Raines stated that there was a separate committee for the campaign issue once the 3/10 committee brought forward the issue to the ballot. She stated neighborhood watch groups were members of the group. She is confused over the discussion/communication breakdown. Ms. Edwards stated there were conversations and requests made for more meetings to get information out and give the group time to plan. She feels this bill is very important and they work closely with the Sheriff.
