#### **PROCLAMATION:**

1. National Public Safety Telecommunications Week April 9 – 16, 2017: A motion was made, seconded and passed to designate April 9 – 16, 2017 as National Public Safety Telecommunications Week in Grays Harbor County. The Proclamation states that emergencies can occur at any time that require police, fire or emergency medical services, and when an emergency occurs a prompt response is critical to the protection of life and preservation of property. Public Safety Dispatchers are the first responders and the most critical contact citizens have to emergency services. This Proclamation is in honor of the men and women whose diligence and professionalism keep Grays Harbor County and citizens' safe.

1. Request Approval, Letter to Quinault Indian Nation re: the Shoreline Master Plan: A motion was made, seconded and passed to approve the letter to Quinault Indian Nation regarding the Shoreline Master Plan. This letter was drafted in response to a letter received from the Quinault Indian Nation dated February 22, 2017, regarding the draft of the Shoreline Master Plan. The letter is informing the Nation that County staffs are currently reviewing the Nation's comments and will be issuing a response. The Department of Ecology, who has dual authority for Shoreline Master Programs under the State of Washington's Shoreline Management Act, will also be participating in developing a response. The Board of Commissioners are also recommending that these policy issues should be discussed through a government-to-government consultation process between both jurisdictions and then the governing bodies will have general principles before administrative personnel begin developing details. This process could take up to one year to complete.

The State Auditor has requested that the County revise the policy to reflect how the County returns donated leave to employees after the leave is no longer needed.
