The Commissioners met in regular session in the Commissioners' Meeting Room, Administration Building, Montesano, Washington, on Monday, August 15, 2016, at 2:00 p.m. Commissioners present were Vickie Raines, Wes Cormier and Frank Gordon. Lori Weiss, Deputy Clerk of the Board, was present to record the meeting. Deputy Prosecutor Norma Tillotson was also present.

#### **HEARINGS:**

1. <u>Supplemental Budget – Solid Waste Plan, \$207,000</u>: There was a public hearing on August 15, 2016 to consider a Supplemental Budget in the miscellaneous Solid Waste Plan in the amount of \$207,000. Notice of this hearing was published in *The Montesano Vidette* August 4, 2016 and August 11, 2016. Commissioner Raines called for a staff report. Brenda Sherman, Budget Director stated this resolution increases the budget for grant revenue from the Washington State Department of Ecology. Appropriations and ending cash are being adjusted based upon actual year to date activity.

Commissioner Raines called for public comment.

There was no public comment and the hearing was closed.

<u>ACTION:</u> A motion was made, seconded and passed to approve Resolution No. 2016-095 authorizing a Supplemental Extension in the budget of the Grays Harbor County Miscellaneous Funds Solid Waste Plan in the amount of \$207,000.

2. <u>Supplemental Budget – General Fund Advanced Expenditures, \$75,000</u>: There was a public hearing on August 15, 2016 to consider a Supplemental Budget in the General Fund, Advanced Expenditures in the amount of \$75,000. Notice of this hearing was published in *The Montesano Vidette* August 4, 2016 and August 11, 2016. Commissioner Raines called for a staff report. Brenda Sherman, Budget Director stated this resolution increases revenue and expenditures for reimbursable election costs. Additional budget is needed due to the number of elections being held this year.

Commissioner Raines called for public comment.

There was no public comment and the hearing was closed.

<u>ACTION:</u> A motion was made, seconded and passed to approve Resolution No. 2016-096 authorizing a Supplemental Extension in the budget of the Grays Harbor County General Funds Advanced Expenditures in the amount of \$75,000.

**3.** Emergency Budget Request – General Fund Non-Departmental (Revised amount), \$207,500: There was a public hearing on August 15, 2016 to consider an Emergency Budget Request in the General Fund Non-Departmental (Revised amount) in the amount of \$207,500. Notice of this hearing was published in *The Montesano Vidette* August 4, 2016. Commissioner Raines called for a staff report. Brenda Sherman, Budget Director stated this resolution has been revised. It was advertised for the amount of \$7,500. This resolution authorizes additional budget for payments to the Copalis Food Bank (\$1,500) and Council of Governments (\$6,000). \$200,000 in transfers out was added to move "one time" sales tax revenue to capital projects funds for software replacement (\$100,000) and facilities capital (\$100,000). The revised resolution total is \$207,500.

<u>ACTION:</u> A motion was made, seconded and passed to approve Resolution No. 2016-097 authorizing a Supplemental Extension in the budget of the Grays Harbor County General Fund Non-Departmental (Revised amount) in the amount of \$207,500.

- 2. Request Approval, Resolution Budget Transfer Stadium Fund, \$175,000: A motion was made, seconded and passed to approve Resolution No. 2016-098 transferring items in the Grays Harbor County Miscellaneous Fund Stadium in the amount of \$175,000. This resolution will increase the budget for transfers out to the fair building construction fund and decrease transfers out to the ORV park fund. Ending cash will be decreased by the difference. This increase in transfers is necessary for funding of the fairgrounds pavilion roof project.
- 3. Request Approval, Resolution Budget Transfer ORV Park, \$35,000: A motion was made, seconded and passed to approve Resolution No. 2016-099 transferring items in the Grays Harbor County miscellaneous fund ORV Park in the amount of \$35,000. This resolution moves budget from capital outlay to transfers out to the Stadium Fund to return cash provided for grant funding purposes. The grants are now complete.
- 4. Request Approval, Office of Public Defense 2017 Indigent Defense Grant

  Application, \$75,881: A motion was made seconded and passed to approve the Public Defense

  Grant application between Grays Harbor County and the Washington State Office of Public

  Defense for 2017. The Office of Public Defense has estimated approximately \$75,881 to Grays

  Harbor County for indigent defense costs which is based on population and the number of felony
  filings.
