


Q3 How many times have you been impacted by disaster events?


Q4 Have these occurred while you have lived (or worked) in Grays Harbor County?


Q12 Do you own or rent your place of residence or business?


Q13 Is your property located in or near a floodplain?


Q14 Is your property located in or near a tsunami inundation zone?



Q15 Is your property in or near a high fire danger area?





Q16 Is your property in or near a high landslide danger area?







potential for disasters in the county, specifically earthquakes and tsunamis. Our local politicians also seem to ignore or pretend the issue doesn't exist, and that's pretty pathetic. What's concerning is, well, everything: A Cascadia event of 9.0 magnitude or greater WILL happen in the future, with DNR / USGS estimating a 15 to 20 percent chance in the next 50 years. That's a very high likelihood, and not a game of dice I'd like to play. The resulting tsunami could range between 30 and 50 feet, though the last Cascadia event generated waves in some locations upwards of 100 ft. There are no current evacuation plans or infrastructure that come close to dealing with such a disaster. Furthermore, USGS / DNR expect permanent coastal subsidence of 10 ft or more. As sea level remains the same, this could add another 10 ft or more to the height of whatever tsunami is generated. This predicted subsidence was reiterated in the recent EIS for the crude oil terminals in Grays Harbor. The Japan earthquake and tsunami is a great example of how permanent coastal subsidence can greatly increase a tsunami's height and strength. This means coastal communities like Ocean Shores and Westport are, sadly, doomed. They lack nearby high ground, and any major earthquake over 8.0 that also generates a tsunami will, in all likelihood, cause severe liquefaction of these coastal soils and sediments, collapsing roads, bridges and any substantial infrastructure people would otherwise use to evacuate. This means, in no uncertain terms, a mass casualty event is highly likely for these communities. If the earthquake occurs during the summer time, with peak tourist activity, the death toll could be frighteningly high. Due to the shape of Grays Harbor, a funneling effect could easily increase tsunami height by the time it reaches the tri-cities. Aberdeen, Hoquiam and Cosmopolis are built on mud-flats, any large buildings will collapse. Critical infrastructure will be destroyed well before the tsunami arrives. Schools, police, fire stations, they're all located in the tsunami zone and built on these weak soils. One would think relocating these critical building to high ground would be a priority, but apparently not as Aberdeen School Districts most recent proposal for a new elementary school in South Aberdeen is located in the tsunami zone below Grays Harbor College. Same goes for the new proposed athletic complex at Bishop Athletic Complex, an even worse location for tsunami and liquefaction. I must admit, for a school district, they aren't that smart. You'd think they'd take after Ocosta and be a bit more forward thinking. Maybe build the new school and athletic complex on top of the same hill Grays Harbor College sits on, there's more than enough room to either side of the college. But I guess we don't take this stuff seriously, it's rather shameful. (To be fair, kids could more easily evacuate up the hill at the College, but wouldn't it be better to build the school out of the tsunami zone to begin with? Then they don't have to hike up a steep hill, and the building, if it's built to withstand the earthquake, won't be completely destroyed by the resulting tsunami and perhaps used for rebuilding...). I would bring up Weatherwax High School... but that ships already sailed. On top of liquefaction, not a single major bridge in Grays Harbor will likely survive a Cascadia event, most are extremely old, not built to any sort of earthquake standards and have foundations based on extremely deep soft liquefiable soils (even the few retrofitted bridges still have shallow foundations in poor soils). This means, well, whoever survives, whatever is left, will be completely cut-off for a long time, months if not longer. Resources will be focused on the Puget Sound and we'll be left on our own. So those who do survive the earthquake, and tsunami, and are inured or need search and rescue, I doubt they'll get it in time. So while the main event will kill thousands, the lack of immediate response will kill many more, as people succumb to their injuries, entrapment in debris, and disease spreads. The one silver lining we have, is that the Grays Harbor Community Hospital is located on a hill, outside the tsunami zone (including the east campus). This would be great, if it wasn't for the fact that the buildings themselves are very old, and will likely collapse in the earthquake. I would say rebuilding these critical facilities to modern earthquake standards should be a top priority. To add to our misery, landslides are extremely likely during Cascadia, especially if it occurs during the winter time / rainy season. Most of our highways are built over unstable ground, along unstable hillsides, or have fill slopes that will fail during the earthquake, further isolating us. Dams may fail as well, the Wynoochee and Skookumchuck will likely go, creating their own inland tsunami / floods that will be just as devastating as their ocean cousins. These are the likely outcomes of a large Cascadia event and I've only touched the surface. After the sad and pathetic federal response to Puerto Rico, a terrible disaster in it's own right, I feel like we're nowhere near prepared for what could be a disaster 1,000 time's worse. I suppose there's a reason people are in denial about this, it's too terrible to fully comprehend. It's daunting, and there seems like there's little hope. But the thing is, without action, without solid planning, investment and

	education, there is no hope. We're our own worst enemies, we have the power to save countless lives. We can relocate critical infrastructure, build or re-build new highways outside the tsunami and liquefaction zones (looking at you SR 105, SR 109, move the highway's to the nearby highlands and build them to modern standards, and maybe reaching the coast after a disaster will be far easier and survivors might be able to leave a lot quicker). We can start replacing the outdated and functionally obsolete bridges with modern ones, build them to modern standards with deep solid foundations. We can build vertical evacuation structures in areas with no hope of reaching high ground, and provide far better evacuation signage for folks near high ground. We can stop proposing new critical infrastructure like schools in tsunami zones when nearby hillsides are easily available (Ocosta had no choice but to build a vertical evacuation structure, there's no nearby high ground there, however Aberdeen School District has no valid excuse, there's plenty of high ground to choose from for a new school). Thanks for the opportunity to take this survey. Ultimately, we need to be smart, think long term, come to terms with the reality of our situation, and do everything we can to improve the chances of survival. It's only a hopeless situation if we chose to continue to do nothing.

39	1. Fuel stations do NOT have backflow preventors on their fuel vents, which are cheap devices that could protect gas and diesel fuel from getting contaminated in a tsunami flow. MASCO for example could lose 6 of its 8 fuel sites in Grays Harbor. Florida amended its building code to protect fuel, why not Washington State? Fuel is the most CRITICAL resource. Without it generators, emergency vehicles, infrastructure clearing, communications won't work. Further, Grays Harbor County buys its fuel from a Tacoma company, which will not be able to deliver fuel following a disaster. If GH County bought it locally, it could dictate, and motivate, a minimum fuel volume be made available. 2. There are hundreds of HughesNet satellite account holders (probably most with generators) who can provide emergency communications, but Grays Harbor County doesn't have an account, nor is it working to coordinate these account holders. 3. Grays Harbor has numerous potable wells, that won't be contaminated by a tsunami or septic, and yet the county isn't making plans on using them after a disaster. GH needs plans to focus on pumping and delivering water 'immediately' after a disaster so as to provide immediate comfort and sanitation to refugees. 4. Grays Harbor has over 6,000 head of cattle (per USDA Survey, which doesn't include many smaller herds), which could be used as subsistence for disaster refugees until federal assistance arrives several weeks later. This only takes advanced coordination with ranchers through contingency contracting operation. 5. Post disaster crime could be greatly reduced if Grays Harbor advance coordinated the thousands of CPL holders (concealed pistol license) into a volunteer security force. 6. Numerous locations don't have cell service (for example my bluff top property and 25 miles of Wynoochee Valley Road. Problem can be solved if county worked with www.vanu.com to place utility pole solar powered 67-watt transmitters.
