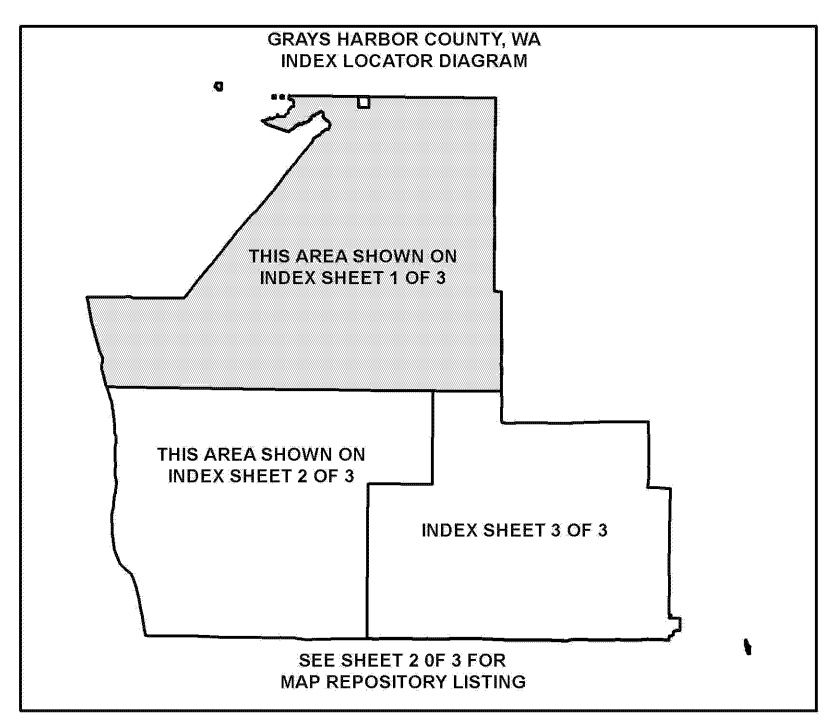
MAP DATES
