For deputy prosecutors there will be a step increase every 6 months until they reach the top end of the scale at which time they will receive Senior Deputy Pay.

Senior Deputy Pay is figured by taking the difference between the Prosecuting Attorney's monthly salary and the Senior Deputy's monthly salary, less longevity, multiplying that by 10% and then adding that sum to the Senior Deputy's monthly salary.

Those deputy prosecutors started on the higher scale will receive a step increase every 6 months until they go into their 6th year at which time they will receive Senior Deputy Pay.
