1) Routine Business:

2) Featured Speakers for topics:

a) Strategic Work Plan Review and Revision: A group exercise was conducted to collaborate on ideas for the future path of the MRC, future topics and ideas. The MRC board needs to be an active board. Garrett or Casey are to make a google document with ideas and topics.

3) Standing Items:

- a) WCMAC: There is a meeting tomorrow at the Port of Grays Harbor building.
- b) SMP: The Grays Harbor County Commissioners approved the SMP but the packet as not been submitted yet. Kyle is to talk with Jane Hewitt with Grays Harbor County Thursday because she is on the VSP project also.
- c) MRC Summit: The date that works the best for the summit is October 25-27th. The Bank of the Pacific has donated \$500, Ocean Gold is to donate \$600, Taylor Shellfish \$1100 and Coast Seafood \$250. The goal was to get \$3000 in donations. RD is going to request funding from FOGH. Please reach out to other businesses for funding. Surfrider can be the fiscal agent for the summit. - Kyle: Oyster farming is going great. They currently have more people employed at the farm than ever before. Over 30 people are currently employed.

- Garrett: WICRI projects are due Friday.

- Amy: There was an internal WDFW meeting earlier in the day on the 12th. This
 meeting was to discuss edits to policy and procedures manual.
- Kevin: Sea Grant has narrowed the director applicants to 4 candidates. Interview are scheduled for the 18th, 20th, 21st, and 22nd all at 2:30pm. These interviews are open to the public and will be live streamed.

- Kristina: The contact was amended for PEI and other tasks. Coast wide MRC coordinator meeting was conducted in May with WDFW.
- Casey: The Clean Water Classic dates have been set. September 22nd or 23rd in Westport. Marine Debris Action plan update. A couple weeks ago, the second workshop was held in Lacey. There was not much coastal representation at the workshop. Full plan is scheduled to be released in August.
