- This site is to be used solely as a research tool. None of the information obtained from the website may be redistributed in any form.
- The information supplied is compiled and presented conscientiously, timely, and as accurately as possible. However, this information is not guaranteed.
- ~~Initially this service will be offered for free. However, in the near future there will be an associated monthly fee and a per use fee. Tentatively, the fee schedule will be a flat \$25 per month with a ten cent assessment per "Detailed Parcel Worksheet" page. The monthly fee is to be paid in advance with the "per hit" fee being collected in the following month. Invoices will be emailed on the first of each month. Accounts may be created for an individual or group. Any account not in good standing will be denied access to the Sales Search Database. Please note that these fees are for the luxury of having the information delivered electronically to your home or office. If you prefer, you may visit the County Assessor's office. The Service is now **free**.~~
- All billing and notifications will be done by email, so an active email account will be required.
- Once the fee schedule is ratified, you will be notified by email of the upcoming billing cycle. Your response and initial payment will be required for continued service from that date.
- Access to the Parcel Sales Search site may be temporarily denied for maintenance or due to circumstances beyond the County's control.
